Style sheet for NJOLAS

NJOLAS follows the Harvard social science citation system. Authors are asked to reference materials such as books, book chapters, journal articles, websites, and blogs in parentheses within the text. A reference list of all documents/sources cited in the text must be included at the end of the article.

Space-consuming references such as legal sources, archive material, non-published documents and so forth can be written in footnotes.

Citing references

An in-text reference should include the author, the year of publication and, if applicable, page number(s).

Sources with one author:

As argued by Pylkkänen (2009, 50)...

Or:

As has been argued (Pylkkänen 2009, 50).

Sources with two or three authors:

Gunnarsson, Burman and Wennberg (2004, 149) mean...

Or

(Gunnarsson, Burman and Wennberg 2004, 149).

Sources with four or more authors:

Eriksen et al. (2015, 591) found that...

Or:

(Eriksen et al. 2015, 591).

Page numbers are written 99-100, but 81-2 rather than 81-82:

(Pylkkänen 2009, 83-4).

(Pylkkänen 2009, 98-104).

If an author has published multiple works in the same year, alphabetize the titles in the reference list and then add a, b, c, etc. to the year:

(Andersson 2015a).

(Andersson 2015b).

To cite more than one reference in a single in-text citation, separate the references by semicolons. If the works are by the same author, use just the year and separate with a comma:

(Ojala 2016; Rasmussen 2015). (Ojala 2013, 2016; Rasmussen 2015).

Material with no personal author. Sources may not have a personal author, but organizations, companies, authorities etc. will function as "authors" in those cases: (OECD 2015).

If a journal article does not have a personal author, use the title of the journal as an in-text reference:

Helsingin Sanomat (2015, 13).

Official sources cited in text: (Regeringens skrivelse 2007/08:39). (SOU 2015:55). (Statens Folkhälsoinstitut 2010).

Regulations:

As a general rule, follow the official national style as far as possible.

Web pages and blogs:

This category concerns references to non-published material online. The same information should be included as other documents (author, year of publication and, if applicable, page number(s). If there is no personal author, use the corporate author (company, organization, authority, etc.). Example: Socialstyrelsen (2014).

National courts:

ECLI numbers may be used where available. As a general rule, follow the official national style as far as possible. State date of decision and use a country abbreviation at the end of the footnote. Ex. Högsta domstolen [HD] [Supreme Court] 2015-11-04, *NJA* 2015 s. 702 (Swed.). Subsequent references to the same case: NJA 2015 s. 702 (Swed.).

Court of Justice of the European Union:

Please follow the practice of citing case law recommended by CURIA (http://curia.europa.eu/jcms/jcms/P_126035/). Ex. Case C-120/78 Cassis de Dijon ECLI:EU:C:1979:42, para. 11. Subsequent references to the same case: Case C-446/03 Cassis de Dijon, para. 11.

Journal article (If the volume is given only as the year, insert the number in parentheses):

Eriksen, Astrid M.A., Hansen, Ketil Lenert, Javo, Cecilie and Schei, Berit. 2015. Emotional, physical and sexual violence among Sami and non-Sami populations in Norway: The SAMINOR 2 questionnaire study. Scandinavian Journal of Public Health 43 (6): 588-596.

For citations of journals consulted online, include a DOI after the reference.
